#### 1. Introduction

The following "General Conditions of Contract for the Supply of Equipment / Machinery" is an integral part of the order. All the indication in the following must be respected by the manufacturer. All particular conditions or exceptions will have to be previously agreed and specifically accepted in writing.

#### 2. Reference Standards

The manufacturer, when accepts the order, implictly confirms that knows laws and regulations relevant for the purpose of the order. The manufacturer and its possible subcontractors are committed to comply with these laws and regulations, both in the design and construction, and in the assembly (if the order also includes this stage).

# 3. Responsability of the Manufacturer

The manufacturer is responsible for the supplied product, within the scope of supply that is indicated in the order and/or the purchase specification. This includes in particular:

- u the design according to the criteria of good state-of-the-art engineering, which takes into account installation, operation and maintenance requirements;
- u the use of materials that are suitable and meet the specifications;
- u the correct operation of working processes (e.g. welding, thermal treatments, controls and tests);
- □ the use of high-quality components;
- □ the use of new components and the guarantee that these components and their relative spare parts will be available on the market for at least five (5) years following the supply.

#### 4. Technical Documents

The documents relating to the supply of the order are an integral part of the contract. The order will therefore not be considered fulfilled without the above-mentioned documentation.

The documentation required by laws must be submitted to ORI MARTIN.

Any other required documents should be explicitly mentioned when defining the order.
